THE STARS ARE ALIGNING

As you have heard from the WRMCA before, more than 575,000 cubic yards of parking lots annually is in play and vulnerable ... if the Wisconsin/UP ready-mix industry is willing to battle for it.

Market forces now at play are making it possible for concrete stakeholders trained in promoting and providing parking lot paving services to claim profitable market share. Unstable world oil markets, high asphalt costs, shrinking asphalt supply, and growing enthusiasm for “green” building have created this emerging profit opportunity.

For a majority of Wisconsin/UP project owners, designers, developers, and specifiers, the concept of a concrete parking lot is a “new” idea, a challenge to the status quo (asphalt pavement) and long-held, firm beliefs (concrete is too expensive, concrete parking lots are too hard to design, concrete parking lots slow down construction schedules).

But now is the perfect opportunity to change those views. Growing awareness by project owners and specifiers of concrete's environmental advantages and the increasingly favorable life-cycle cost benefit of concrete parking lots due to high asphalt prices provides a real opportunity for concrete to gain significant, profitable parking lot market share. However, to successfully capture this market share will require a winning strategy, tactical promotion and technical support, and a united army of associates, producers, and concrete contractors.

The Parking Lot Promotion Academy will provide the tools needed for the army to go out and successfully promote concrete parking lots to project owners, designers, developers, and specifiers. The 2nd Annual Academy will share best practices for effective concrete parking lot promotion, discuss project construction and design issues, introducing new, effective promotion tools, lead generation and tracking systems, and team promotion (one contractor + one ready-mix producer) strategies.

WRMCA Offering Pervious Contractor Certification October 16

Ancillary Concrete Certification Letter

Below is the Certification letter for WISDOT jobs and particularly the "Lesser Critical" Ancillary Concrete Specification mixes. It is a draft that can be used and modified as needed but has all of the pertinent information on it for what DOT will expect to see in the files at the GC for DOT work you supply on projects from the December, 2008 letting and on through 2009. This means that testing will not need to be done on every single small or large load that is sent out for the Ancillary Spec work. You will still need to be certain that it will meet the QMP specs just like in the past but there will be a cost savings (and personnel savings) for all concerned.

As a result of our success with this letter, the NRMCA plant specification in the current Ancillary Spec will not be in the 2009 WISDOT specification for the Ancillary Concrete.
